#### **TOWN OF BALDWIN**

**RESOLVED**, that the rules governing the conduct of Public Hearings in the Town of Baldwin are as follows:

- A. The Hearing Officer, unless otherwise designated shall be the Town Supervisor for the Town.
- B. The Hearing Officer shall decide all questions of procedure arising from the Public Hearings.
- C. The Members of the Town Board shall not participate in the Public Hearing unless they so desire.
- D. The Hearing Officer shall maintain order at all times during the Public Hearing and shall have the right to order a person removed if such person becomes disorderly.
- E. All persons desiring to speak shall speak for a period not exceeding five minutes, and shall be limited to the subject matter of the Public Hearing as contained in the Legal Notice thereof.
- F. All persons desiring to speak shall first be recognized by the Hearing Officer, and then must state his or her name, address and whether or not he or she is acting in a representative capacity, and if so, the name of the person, firm, or corporation he or she is representing.
- G. No person shall speak more than once until every person choosing to speak shall have spoken, and no more than twice without permission of the Hearing Officer.
