HIGHWAY

Paul Tillotson reported that the Highway Department cleaned up all the old steel and steel pipes out back and turned in checks for that in the amount of approximately \$4,000.00 to \$4,200.00.

We had a good snow storm with about 36 to 40 inches of snow. A couple trucks got stuck. The power steering pump went in the 2017 truck. It is fixed now and working good. It was approximately \$1,700.00 to get fixed.

We had an ice storm and everything worked good for that.

The 6-Wheeler went down, thought it was the rear end, found out it was a broken rim. Instead of \$4,000.00 to fix it, this ran the Town \$1,000.00 to fix.

There were some bad spots and they were fixed with some bedding stones.

The Highway Department started hauling in some more sand to keep pile built up.

PUBLIC WELFARE AND SAFETY COMMITTEE

Paul Steiner on behalf of the Fire Department thanked Paul Tillotson for the help to clean them out. Chemung County attempted it right after the 40 inches but Paul Tillotson came and cleaned up after that and did a good job like always.

He wanted to remind everyone to keep PPE up regarding COVID.

The Fire Department sign is up and running.

BANNER PROGRAM COMMITTEE

There is a local individual that will be doing a hero banner for the Town.

Supervisor Purvis asked if the two telephone poles in front of the Fire Garage on other side are Town poles or NYSEG poles, to which Paul Steiner asked if there was anything on them (there is not) and if not then they may be the Towns but they would have to be looked at. Paul Tillotson and Paul Steiner said that they would have to look at the poles and would let Supervisor Purvis know.

INTERNET PROGRESS COMMITTEE

Councilman Sherwood stated he would email Haefele tomorrow evening to touch base with them as to the internet status. Paul Steiner stated that the Fire Department has an appointment on 02/08/2021. There was a question as to whether or not the Franchise Agreement between Haefele and the Town of

Baldwin provided for free internet service to the Town Hall, the Highway Garage and the Fire Department. Faith Marmor will email Councilman Sherwood the Franchise Agreement for his review on this issue. There has been no communication with regards to Spectrum or extensions of service.

EXECUTIVE SESSION


The Board did not go into Executive Session.
