

**TOWN OF BALDWIN
TOWN BOARD MEETING
MAY 12, 2021**

THIS REGULAR MEETING of the Town of Baldwin was held at the Town of Baldwin Town Hall and called to order at approximately 6:00 p.m. by Supervisor Purvis. Those present were Councilwoman Purvis and Councilman Conklin. Councilman Sherwood and Councilman Steiner were absent.

Also present was Paul Tillotson, Faith Marmor, Anna Pirro and Brian Hyland.

PUBLIC COMMENTS

There were no public comments.

COUNTY LEGISLATURE

Brian Hyland spoke regarding the following:

1. Beaver Pond - He received a few phone calls regarding the Beaver Pond. Mark Watts relayed to him that the road was in danger of washing out because the drains were plugged and this is the reason why the Beaver Pond was drained, the feeling is that they probably over did it.
2. Sheriff Schrom - There are concerns throughout the District about Law Enforcement. He will be attending the Town of Baldwin's June Town Board Meeting. He is going to listen and wants to be responsive. He did a presentation in Van Etten that went very well.
3. Rescue America Funds - These funds will be coming in and Chemung County is going to get \$16 million in two payments of \$8 million each. He is sending an email with all the criteria, this email breaks down Federally, by view of what can and cannot be done with these funds and then the County and how they plan on handling the same. He is requesting an email as to how the Town has been affected, where the money is needed, a rough dollar amount, etc. Supervisor stated that the appropriate plan would be to allocate it on a percentage basis accordingly to population as this is the fairest and is equal. Brian Hyland said that his concern is that we need a lot of infrastructure and this is one of the things this money can be used for, as well as Broadband expansion, roads, bridges, etc., and we need that kind of help here. It concerns him that there is no allocation for Agriculture or Agribusiness.
4. Casella Funds - The application is online. If the playground damage is not covered by insurance, some of these funds may be able to go towards these damages. Faith Marmor will check with NYMIR as to whether the playground is covered on the Town's insurance.

MINUTES

A Motion was made to accept the April 14, 2021 Town Board Meeting Minutes by Councilwoman Purvis, seconded by Councilman Conklin, All Ayes.

TOWN CLERK

A copy of the Planning Board Minutes from the 4/22/2021 Public Hearing was given to each Board Member.

A call was received from an individual as to a dog incident. This individual was in Steuben County at a campground and a resident of the Town of Baldwin had a dog that attacked his canine and killed it. There was a lawsuit which was held in Steuben County Court and a copy of the Order from the Court was given to Faith Marmor for reference should there be an incident that happens again with the same Town of Baldwin resident and their dog. A copy of the Order was given to each Board Member. Faith Marmor will keep this information on file at the Town Hall. There was question as to whether the dog is licensed in the Town. Faith Marmor will check as to the status of same.

HIGHWAY

Paul Tillotson reported on the following:

The Highway Department has been hauling Item 4 to do Norway Road. They have 500 tons more to get for that project.

They have ditched Oak Hill, Mathews, Perryline and Braybrook roads with the grader.

They graded bad spots on Ridge Road until they can do the whole road, hopefully another week.

They helped the Town of Elmira do some millings which they hauled in for ourselves.

The 2006 Volvo Truck front springs went and were fixed.

Pot holes have been filled throughout the Town.

They have hung the Hometown Hero flags up.

They started grading this week but was slow due to rain and sometimes snow that we have gotten in the last month and because of this it will take them a while to get around the Town this year.

As to the tractor, the 820 John Deere tractor fuel injector pump is bad. He called John Deere and they do not make them anymore. He found one in Iowa and it will be here Friday or Monday. The cost for the pump and shipping is \$1,265.56 and \$1,000.00 for the core. The Town should think about upgrading the 1972 tractor to something more modern. Terry from Bradco looked the tractor over and it will be

about \$5,000.00 we can get for this tractor. He stated that most tractors will be around \$40,000.00 for a used tractor and he did have three online prices/quotes to show the Board.

EXECUTIVE SESSION


The Board did not go into Executive Session.
