JUNE 8, 2022**

**THIS REGULAR MEETING** of the Town of Baldwin was held at the Town of Baldwin Town Hall and called to order at approximately 6:00 p.m. by Supervisor Purvis. Those present were Councilwoman Purvis, Councilman Conklin and Councilman Collins. Councilman Smith was absent.

Also present were Faith Marmor, Robin Rosekrans, Paul Tillotson and Anna Pirro.

**PUBLIC COMMENTS**

There were no public comments.

**COUNTY LEGISLATURE**

The County Legislature was not in attendance and no report was given.

**MINUTES**

A Motion was made to accept the May 11, 2022 Town Board Meeting Minutes by Councilman Conklin, seconded by Councilwoman Purvis, All Ayes.

**SUPERVISOR**

We received an explanation from NYSEG regarding their price increases.

Chemung County issued a letter as to inflation with costs of fuel, office supplies, repairs and maintenance, employee travel, equipment etc. being more and they are looking at overruns in excess of \$1,000,000.00.

**TOWN CLERK**

There is a Rabies Clinic in Bath at the Town Barn on Wilson Avenue on June 17, 2022 from 5:00 to 7:00 p.m. This is a drive through clinic.

We received a NYS DOH Publications list and will not be ordering anything at this time.

**HIGHWAY**

The Highway Department finished grading roads and still putting dust control down and will continue when get more in.

They hauled in stone for the stone and oil project on Elston Hollow Road and hope to do that June 14<sup>th</sup>. The road will be closed for that day. *Faith Marmor will put this information on the town's website.*

They helped the Town of Elmira for a couple days.

They started to mow along the roads and have the other side of town to do for a final time.

We need to change the budget amount and do an addendum to increase both the Revenue and Expense to an increase of \$28,672.26 for both accounts. This is a wash. The Budget currently is at \$260,000.00 for both accounts and right now there is \$288,672.26 for Chips. A Motion was made in the form of a **Resolution 24-2022 (R6-2022)** to agree to increase the Chips Revenue (DA3501) and Appropriations (DA5112.2) each for \$28,672.26 by Councilman Collins, seconded by Councilman Conklin, All Ayes.

**EXECUTIVE SESSION**


The Board did not go into Executive Session.
