TOWN OF BALDWIN TOWN BOARD MEETING AUGUST 14, 2024

THIS MONTHLY MEETING of the Town of Baldwin was held at the Town of Baldwin Town Hall and called to order at approximately 6:00 p.m. by Supervisor Purvis. Those present were Councilwoman Purvis, Councilman Wolcott, Councilman Smith and Councilman Collins.

PUBLIC COMMENTS

Robin Rosekrans wanted to thank EMS.

LEGISLATURE

He spoke briefly on the No Camping in the City rule/law that is looking to be passed.

The Fair was good this year, better than it has been. They are planning on running the Fair five days next year.

MINUTES

A Motion was made to accept the 7/10/24 Town Board Meeting Minutes with no changes by Councilman Collins, seconded by Councilman Wolcott, All Ayes.

TOWN SUPERVISOR

The Supervisor report is attached to these Minutes.

The Town Hall flooded from the storm, 2" to 3", mud through rooms, damaged a lot of records. Councilwoman Purvis cleaned for two days. Paul Tillotson was the first to notice. Barb Harding asked if the Town Board ever passed the LGS-1 - Retention of Records as this would allow for only 6 years of records/returns needed to be kept/provided for any purpose, as she believes this would be helpful to pass due to the flooding and damage of some records. A Motion was made in the form of a **Resolution 22-2024 (8R-2024)** to adopt the *Retention and Disposition Schedule for New York Local Government Records (LGS-1)* by Councilman Collins, seconded by Councilman Wolcott, All Ayes. A copy of this Resolution is attached to these Minutes as well as retained by the Town Clerk files.

We received the Board of Elections 2025 estimate of \$3,370.00. A copy will be given to Barb Harding. We received a Summer Storm email from Chemung County. New York is seeking Federal Assistance for costs incurred from the severe weather events on July 15, 2024. We will keep tabs on this.

TOWN CLERK

The Town Clerk report is attached to these Minutes.

A free rabies clinic was offered on 8/01/24 at the Town of Chemung. This was placed on the website for residents.

Faith Marmor will be ordering a new mailbox for the Town Hall outdoor wall by the main entrance. The cost is approximately \$85.00. She requested approval from the Board for this mailbox to be shipped to her house to be sure it was delivered as the Highway Department is busy this time of year and may not be out back to receive a package and there is no one at the Town Hall full time. The Board approved, All Ayes.

2025 Budget requests were submitted by email to the City of Elmira for Animal Control and to the Chemung County Treasurer's Office, requesting an estimate or amount for budget purposes prior to the October Town Board Meeting if possible.

The Chemung County Fair free admission tickets availability by the Town Clerk and Fire Department was placed on the website per Councilman Wolcott's request.

The SAM registration (Federal Grant Program) was updated for another year.

The Town Clerk will be on vacation the week of August 26, 2024. This information will be placed on the Town's website and main entrance of Town Hall.

HIGHWAY

The Highway Report is attached to these Minutes.

The heater, which also runs the air conditioning unit, at the Town Hall has not been working. Paul Tillotson stated problems with getting parts for this unit as it is 22 years old. The Board may want to consider putting money aside for a new heater for the Town Hall. He will look into pricing for a new unit through Mike's Heating and Air, Bills and HEP.


