The 1995 Volvo cannot be sold, it is too far gone, the floor is completely rotted and the frame is cracked the whole way through. Paul Tillotson asked the Board to allow for the 1995 Volvo to be sent to scrap. A Motion was made in the form of a **Resolution No. 27-2025 (10R-2025)** to allow Paul Tillotson to scrap the 1995 Volvo by Councilman Collins, seconded by Councilman Wolcott, All Ayes.

Daniel Bates has given his two week notice, his last day working for the town will be 10/17/25. The Highway Department for the town will be looking to hire an employee for this position. This information will be posted on the town's website and on Indeed.com.

#### **NEW BUSINESS**

2026 PRELIMINARY BUDGET - Barb Harding presented the Preliminary Budget for 2026 to the Board. She stated that from January 2025 to September 2025, the town has a net income of -\$153,392.00. There is \$162,450.00 in Chips, still in the positive. She had a few suggestions: 1. Take one year with only absolutely that which needs to be done and purchased. 2. Use the Chips money to pay the tractor off (would save the town \$10,000.00 in interest, could be paid off with Chips after the first of the year). 3. Only fund the HRA at 70%. If the town were to do these things, it is possible that a truck could be purchased end of next year. The Preliminary Budget for 2026 provides for Chips only at \$120,000.00 and for potential pay off of the tractor, the funding of the HRA is at 100%. After discussing these suggestions and the Preliminary Budget for 2026, a Motion was made in the form of a Resolution No. 28-2025 (10R2-2025) to approve the 2026 Preliminary Budget with the change of funding the HRA at 70% by Councilman Collins, seconded by Councilman Smith, All Ayes.

PAYMENT OF BILLS - A Motion was made to pay the General Bills for September 2025 No. 130-142 in the amount of \$16,839.53 by Councilman Wolcott, seconded by Councilman Smith, All Ayes. A Motion was made to pay the Highway Bills for September 2025 No.135-150 in the amount of \$19,285.21 by Councilwoman Purvis, seconded by Councilman Collins, All Ayes.

#### **PUBLIC COMMENTS - MEETING**

Robin Rosekrans requested confirmation that a truck for the Highway Department was not being purchased. This was confirmed.

#### **EXECUTIVE SESSION**

A Motion was made to go into Executive Session by Councilman Collins, seconded by Councilman Smith, All Ayes.

A Motion was made to go out of Executive Session by Councilman Collins, seconded by Councilman Wolcott, All Ayes.

#### ADJOURNMENT

A Motion was made to adjourn the meeting by Councilman Wolcott, seconded by Councilwoman Purvis, All Ayes.
